MARCH 20 EXECUTIVE MEETING

President Frank Wroblewski, W2XYZ called the meeting to order at 6:30 PM at the Red Cross Building. It was attended by Frank Wroblewski, Howard Suffill, Bill Shockley, Joe Dreifuss, Steve Jackson, and Bruce McLeod.

New Equipment Proposals

The club officers met mainly to discuss the feasibility of upgrading the HF equipment in the clubhouse. The goals of the upgrade are to provide two operating positions with close to identical transceivers, to introduce and/or expand computer control of the rigs, to provide an operating environment that is easy to learn and operate, to accomplish all this without incurring

extraordinary expense. We discussed the addition of a new Icom IC-718 (priced at \$709) to complement the existing model. We also discussed shelving the existing IC-718 and acquiring two Yaesu FT-450D's or maybe two Yaesu FT-950's. The former are priced at around \$875 apiece. The latter at around \$1260 apiece.

Another option is of course to keep the status quo. Nobody thought that this was a good idea.

Some of the monies required will come from the sale of outdated equipment that the club currently owns. Frank suggested that we should be able to make up \$1500 from such a sale. Hopefully we can determine what to sell in time for the May 4th hamfest. Two or three scenarios will be generated and submitted to the membership via email. These scenarios will suggest models, makes, and approximate prices. Comments and suggestions will be appreciated. It would be nice if much of the new equipment were on hand for the coming ARRL Field Day in June.

Staffing the Clubhouse on Saturdays

Frank noted that the 2nd Saturday of the month is about all the coverage he could manage. There should be one person available to unlock (and lockup) the clubhouse every Saturday. Preferably it should be an officer since the officers have building access. This topic was not discussed in detail because we spent the whole time talking about equipment considerations.

RETIREMENT COMMUNITY QUERY

I am looking into two over-55 retirement communities - Equestra in Farmingdale, or The Fairways at Lake Ridge in Lakewood. I am interested in finding out if there are any radio amateurs in either place, and what their experiences with antennas are.

The Home Owners Associations generally forbid tower-mounted antennas but the wording about wire antennas is vague. (Satellite dishes up to 36 inches diameter are permitted.)

A SURVEY OF GSARA MEMBERS

We wish to ask GSARA members if they want to upgrade the clubhouse stations. We'd like to get modern, easy-to-operate radios, all of the same type. The advantages of the easy instead of high-performance style is; operation is quick to learn and remember, and most bells and whistles are not used in contests or Field Day anyway. Modern radios integrate with computers and amplifiers easier than the older equipment now being used.

We'd like to hear the members opinions on whether to upgrade or not and also on how we should upgrade, if that is what the majority would like to happen. Although there are many manufacturers and dozens of models to choose from we narrowed the choices down to a few.

A. No upgrades

B. Keep the current IC-718 and purchase a new IC-718 with filters and tuner for approximately: $\$745+300+200 = \1245

C. Purchase two new Yaesu FT-450D's with filters and tuner included at approximately: $\$1900-140(\text{rebate}) = \1760

D. Purchase two new Yaesu FT-950's (filter not needed) at approximately: \$2840

E. Don't purchase radios, just sell the two Collins amps and if necessary, add money from the treasury and buy a solid-state, no-tune amplifier such as: Ameritron ALS-600S for \$1500.

Where does the money come from? If we were to upgrade, we would attempt to sell the two Kenwood TS-930S transceivers, the Collins 30L1 amplifier, and the Collins S1 amplifier (as is). Depending on the amount of funds received from these sales, we may or may not have to use money from the treasury, again depending on the choice of replacement radios.

Please let me know your preference (A through E) by an e-mail vote, or verbal reply by phone or at the meeting on Apr 3 (for those without email).

1946 FIELD DAY RESULTS

From the *Red Bank Register* March 13, 1947

NATIONAL RADIO CONTEST WON BY SHORE GROUP AMATEUR OPERATED STATION AT CRAWFORD'S HILL

The Jersey Shore Amateur Radio association (*one of the two clubs that later formed GSARA – Ed*) won first place in the yearly competition sponsored by the American Radio Relay league of Connecticut. The contest was open to all amateur radio associations in the United States and any amateur operator. The contest was held last June.

The purpose of the contest, as explained by Robert Brandt of Newman Springs road, president of the shore group, is to test and develop emergency powered equipment. The Idea of the contest was to set up field stations and contact more amateur stations in the United States than any other contesting group. The Jersey Shore group operated eight transmitters and used 27 operators at their field station at Crawford's hill, between Hazlet and Holmdel. This is considered the highest point in Monmouth County.

Mr. Brandt reports that 309 other stations were contacted and gas generated motors supplied the power. The group operated on all amateur bands from 3.5 to 144 megacycles. The call letters used were W2FC. The local group made 9,621 points to acquire the highest total in the contest. The results of the contest were just made official recently.

In several pre-war competitions the Jersey shore association won several second-place honors. Edward Chinnock of Red Bank is vice president of the group. The local unit will hold a convention in Asbury Park in the fall for the Hudson division of the American association. The Hudson division comprises most of the states of New Jersey and New York.

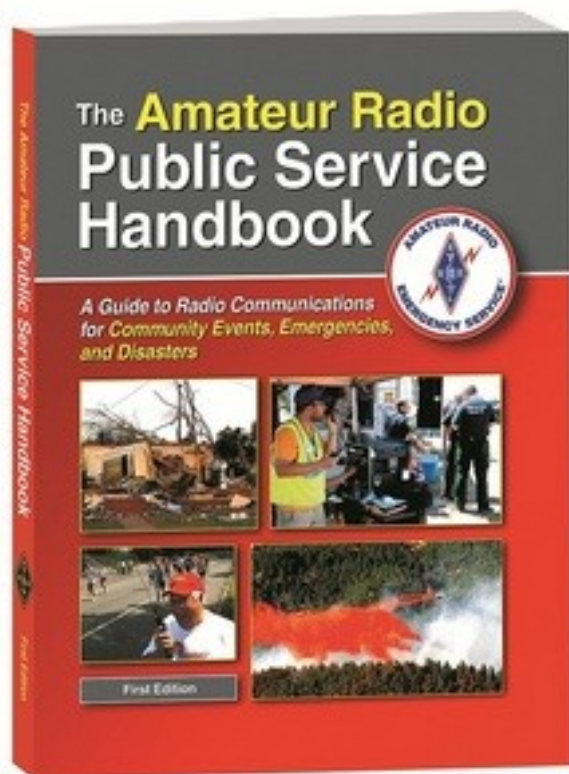

The [Amateur Radio Public Service Handbook](#) is now available from amazon.com for the Kindle.



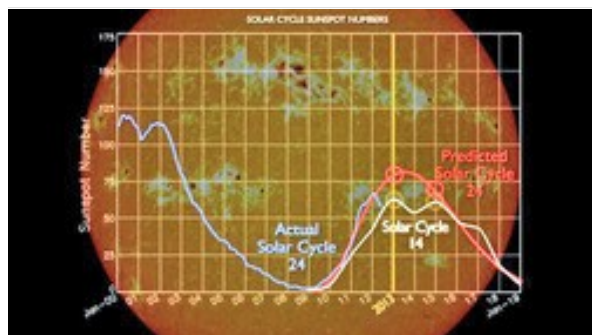

DOUBLE PEAK FOR CYCLE 24?

According to NASA, the current solar cycle --



This NASA image compares Solar Cycle 14 (shown in white) with our current cycle, Solar Cycle 24 (shown in blue and red). Dean Pesnell of NASA's Goddard Space Flight Center is predicting that Solar Cycle 24 will have a "double peak," just as Solar Cycle 14 did in the first decade of the 20th century. Pesnell predicts that Solar Cycle 24 will peak twice -- once in late 2013 and again in 2015. View a larger image [here](#).

Solar Cycle 24 -- should hit its "solar max" sometime in this year, but so far, solar activity has been relatively low. According to an article by NASA's Dr Tony Phillips, this period of quiet has led some observers to wonder if forecasters missed the mark. But solar physicist Dean Pesnell of NASA's Goddard Space Flight Center has a different explanation: "This *is* solar maximum. But it looks different from what we expected because it is double peaked." Pesnell noted similarities between the current cycle and Solar Cycle 14, which happened between February 1902 and August 1913 and experienced a double peak. If the two cycles are in fact twins, he said that "it would mean one peak in late 2013 and another in 2015." Read more [here](#).

APRS GOES UNDERGROUND

Bob Bruninga, WB4APR, led a group of radio amateurs earlier this month to Mammoth Cave -- the world's longest known cave system -- at Mammoth Cave National Park in Kentucky to test how the Automatic Packet Reporting System (APRS) can be used as a means to extend radio communications underground. "When used underground, VHF and UHF radios can only work

within a few hundred feet of each other and only when in the line of sight of another radio," Bruninga explained. "This makes routine use of these radios of little value when underground; however, when APRS radios act as packet digipeaters, these few hundreds of feet can be extended by an order of magnitude." Bruninga, a senior research engineer at the US Naval Academy, developed APRS as a global, on-air protocol for supporting handheld position reporting and text messaging via VHF radio. TEN YEARS AGO

FIFTEEN YEARS AGO

From the April 1998 Propagator: 16 members have volunteered to receive The Propagator by e-mail only, thus saving GSARA some printing and postage costs. Don Pingitore, formerly KC2BTF upgraded to Advanced and changed his call to KG2NV. Chapter 138 of the QCWA will hold their annual awards banquet on May 3 at the Fort Monmouth Officers Club. There was an article giving the history of why the code speed for an amateur license was increased from 10 wpm to 13 WPM on June 3, 1936. Lowell Bellingham, W2HXJ became a silent key.

\$10,000 FINE FROM FCC

On February 25, the FCC issued a Notice of Apparent Liability for Forfeiture (NAL) in the amount of \$10,000 to Jared A. Bruegman, ex-KC0IQN, of Bolivar, Missouri. The FCC said that Bruegman "apparently and willfully violated Section 301 of the Communications Act of 1934, as amended by operating an unlicensed radio transmitter on the frequency 14.312 MHz in Bolivar, Missouri." Bruegman -- who does not currently hold an Amateur Radio license -- was operating in the phone portion of the 20 meter band that is assigned to the Amateur Radio Service on a primary basis; his Amateur Radio license expired in 2010. As a former Technician class licensee, he did not have privileges to operate in that portion of the 20 meter band when he held an Amateur Radio license.

In December 2012, the FCC's office in Kansas City received a complaint from an Amateur Radio operator, reporting interference on 14.312 MHz. Upon investigation, agents from that office heard a male voice transmitting on the frequency 14.312 MHz. Using direction finding equipment, the agents located the source of the radio frequency transmissions to a transmitting antenna mounted on a pole next to Bruegman's residence. The agents determined that the signals on 14.312 MHz exceeded the limits for operation under Part 15 of the Commission's rules and therefore a license was required to transmit. The agents further discovered that Bruegman did not hold a license to operate a radio transmitter on 14.312 MHz at or near that location.

The agents determined that the source of the transmissions was coming from an unlicensed radio transmitter from a bedroom in Bruegman's residence. "Mr Bruegman was the only person present in the bedroom and the only male in the residence during the inspection," the NAL stated. "Mr. Bruegman admitted to the agents that he owned the radio transmitter. The agents observed that the transmitter was turned on and tuned to 14.311 MHz. Mr. Bruegman told the agents that he had no current Commission licenses, but that he previously held an Amateur Radio license, call sign KC0IQN. Mr. Bruegman told the agents he would remove the microphone from his transmitter and only use it as a receiver."

Section 503(b) of the Communications Act provides that "any person who willfully or repeatedly fails to comply substantially with the terms and conditions of any license, or willfully or repeatedly fails to comply with any of the provisions of the Act or of any rule, regulation, or order issued by the Commission thereunder, shall be liable for a forfeiture penalty." In addition, Bruegman was found to be in violation of Section 301 of the Communications Act, stating that "no person shall use or operate any apparatus for the transmission of energy or communications or signals by radio within the United States, except under and in accordance with the Act and with a license granted under the provisions of the Act."

Bruegman has until March 27, 2013 to pay the forfeiture in full, or file a written statement seeking its reduction or cancellation.

This was a privately organized expedition in March 1988 to ski from the top of the Soviet Union to the top of Canada crossing the North Pole. All communication was via amateur radio and the skier's position was relayed via Oscar 11 on 145.825 MHz. Many GSARA members monitored the satellite as did schools throughout the country.
