However, the law says that you must notify the FCC of any change in address so if you're law-abiding, you will notify the FCC of any changes.

There was an obit in the Asbury Park Press for W. Wallace Miller of Tinton Falls and formerly of Sea Girt who was listed as a ham operator. However, my search of the call sign database brought up nothing. Since he was 92 when he died, perhaps his license had expired. NEW IRC AVAILABLE

The Universal Postal Union (UPU) has announced that a new International Reply Coupon (IRC) design <<http://www.dailydx.com/2007irc.jpg>> has been selected. Radio amateurs often enclose IRCs when QSLing DX stations directly to cover the cost of return postage. The new design, known as "Beijing Model No. 2," was submitted by Volodymyr Taran, a graphic artist from Ukraine. Chosen by a jury of 40 UPU member countries, the coupon design was inspired by Michelangelo's painting on the ceiling of the Sistine Chapel -- two fingers about to touch framed in a postage stamp, representing the notions of communication and exchange. The new IRC will be valid until December 31, 2009. The current IRC is valid through December 31, 2006. MAJOR CHANGES TO UK RULES

The Radio Society of Great Britain (RSGB) reports radio amateurs there soon will no longer have to keep a log unless telecoms regulator Ofcom specifically requests it. Other significant rules changes Ofcom has announced include a substantial relaxation of regulations regarding unattended operation and remote control. Amateurs will be able to use 10 mW on any amateur band for remote operation within a 100-meter range. "Interestingly," RSGB commented, "Ofcom appears to have formally recognized Amateur Radio as a leisure activity as well as a self-training hobby." In 2005, Ofcom unveiled a laundry list of changes to the Amateur Radio rules, including the introduction of a lifetime license that could be renewed free of charge via the Internet. The lifetime license and the new changes to the licence Ofcom has just announced go into effect in October 2006. RSGB encouraged UK amateurs to read and file comments on Ofcom's documentation <<http://www.ofcom.org.uk/consult/condocs/aradio/1/ifetimelicense>> on the new license format.

"MAGIC BAND" DOES ITS THING

Stations in several parts of the US took advantage of a monster opening on 6 meters -- the "Magic Band" -- Wednesday, July 12. The Daily DX <<http://www.dailydx.com>> Editor Bernie McClenny, W3UR, who also edits "How's DX?" for QST, says the band began warming up at his Maryland QTH before sunrise, but the biggest opening occurred just before 2100 UTC.

"The band stayed open to Europe until just after 0000Z today," McClenny said July 13. He credits fellow 6-meter DX chaser Marty Green, K2PLF, with tipping him off. "I ran downstairs and could not believe my ears," McClenny enthused in the July 13 edition of The Daily DX. "I have never heard conditions so good and so widespread into Europe."

McClenny said "the band was packed" from about 50.066 to well above 50.200 MHz with CW and SSB signals and even a few weak digital signals. So bountiful were the 6-meter DX spots, he recounts, "I didn't know where to begin." McClenny said conditions were so good "stations with 10-foot high antennas and 5 W were making it across the pond."

QST's "World Above 50 MHz" Editor Gene Zimmerman, W3ZZ, called it "probably the best 6 meter Es [sporadic E] opening of all time" into Europe. "I worked about two dozen Europeans as far east as Bulgaria but no new countries," Zimmerman said.

Rich Lawrence, KB1DMX, in Connecticut reported hearing stations in Italy, France, Spain, England, the Canary Islands, Serbia, Belgium and the Azores.

Rick Tharrington, KD4JRX, in North Carolina was among those posting exclamatory reports to the SixClub reflector. "I could not believe the European stations on the band," he said. "It sounded like 20 meters for while!" He worked EH8BPX and ON4IQ, among others, with 59 reports. "The magic band is working its magic today!" he added.

On the same reflector, Paul Lenharr, KB3NDS, reported working 18 stations in just under 45 minutes from his modest station -- 100 W to a dipole at 35 feet -- in Maryland. "This was one of the best openings for me since I started using 6 meters," he said.

In another SixClub posting, Jack Shutt, W9GT, said the band "was hopping" at his QTH in Indiana the evening of July 12, but he couldn't hear any DX. "Six meters, however, was open coast to coast," he reported, noting that he worked several stations to his west, including a couple in Nevada and one in California.

"I hope we can enjoy these conditions for a while yet," Shutt said. "Sure is fun when 6 is open!"

McClenny said Jose DaSilva, N4IS, in Southern Florida, may have been the first US station to work Montenegro on 6 meters when he snagged YU6DZ at 1559 UTC. "After four seasons on the band," McClenny concluded, "I would have to say that overall this has been the best -- and we are just about at the bottom of the sunspot cycle!"

CANADIAN TEAM WINS WRTC-2006

Canadians John Sluymmer, VE3EJ, and Jim Roberts, VE7ZO (ex-VE3IY), officially topped the 46-team field at World Radiosport Team Championship 2006 (WRTC-2006) in Brazil <<http://www.wrtc2006.org>> July 8-9. As PT5M they logged nearly 2.44 million points to take home the gold. US teams took the second and third positions for silver and bronze medals, respectively. But the appearance in one log of a large number of what officials are calling "phantom QSOs" took another team out of medal contention.

Earning the silver medal was the US-West team of Californians Dan Craig, N6MJ, and Dave Mueller, N2NL, with nearly 2.32 million points from PW5C. The national special invited team of Doug Grant, K1DG, and Andy Blank, N2NT -- operating as PT5Y -- landed in third place with almost 2.1 million points. They had been in fourth place in the preliminary "Scoreboard" results as the event ended at July 9 at 1200 UTC. The final five changed, however, once WRTC-2006 officials reviewed all logs.

Preliminary Scoreboard numbers had the Serbia-Montenegro team of Ranko Boca, YT6A, and Djurica Maletin, YT6T -- operating as PT5L -- scrambling from 11th to third place in the final hour of the event. When the smoke cleared, however, they ended in 11th place.

In a statement <<http://www.wrtc2006.com/release59.html>> July 14, WRTC-2006 officials explained that the PT5L log contained an unusually high number of "uniques" -- call signs that appeared rarely or not at all in the logs of more than 1000 IARU contest participants or of other WRTC-2006 competitors. The officials said recorded audio from PT5L confirmed that the QSOs had in fact taken place.

"It appeared to the judges, from listening to the recording while examining annotated log extracts identifying the 'uniques,' that there was a small number of stations, probably more than one, feeding 'phantom QSOs' to PT5L," the WRTC-2006 statement said. Signing the statement in addition to Atilano de Oms, PY5EG, as WRTC-2006 steering committee chair, were judges David Sumner, K1ZZ, and Roger Western, G3SXW, and Log-Checking Committee members Larry "Tree" Tyree, N6TR, and Phil Goetz, N6ZZ.

As a result, the judges and log-checking committee decided to reduce the threshold for determining a unique QSO to a relatively small number of logs and to delete all uniques from the logs of all 46 competing teams.

While most teams lost about 15 QSOs, the action resulted in the deletion of 240 contacts -- nearly all "manufactured" at the other end -- from the PT5L log and the loss of the bronze medal. The five WRTC-2006 officials said it appears most likely that the "phantom QSOs" were intended to sabotage either one or both of the PT5L operators specifically or a randomly selected WRTC station.

"Such behavior, by amateur operators outside the WRTC event itself, is both reprehensible and illegal and deserves to be thoroughly investigated," the officials said. "However, doing so within the time frame of the WRTC event was impossible."

Taking the fourth spot with some 2.02 million points was the Ukrainian team of Yuri Onipko, UT4UZ, and Dimitry Stashuk, UT5UGR, who competed as PW5X. They'd showed up in fifth place in the preliminary standings. Rounding out the top five was the PT5D team of Stefano Brioschi, IK2QEI, and Stefano Galli, IK2JUB, of Italy. They racked up nearly 1.99 million points.

These special awards were also presented: PW5U (XE1KK/XE1NTT) for the most CW QSO points among stations with at least 35 percent SSB QSOs; PT5N (9A8A/9A5K) for the most SSB QSO points; PW5K (ES5TV/ES2RR) for the most accurate log among the top 20 finisher, and PW5G (IZ3EYZ/9A1UN) for the top score among Bi-National Young Team participants.

WRTC-2006 selected 47 teams to take part, but only 46 competed because the Czech Republic team of OK1FUA and OK2RZ was unable to get to Brazil because of an airline service suspension. Citing other commitments, three-time WRTC winners Dan Street, K1TO, and Jeff Steinman, N5TJ, did not participate in this year's event in Brazil.

MAINTAIN YOUR ADDRESS WITH FCC

The FCC has suspended two Amateur Radio licenses because the holders had failed to maintain correct mailing addresses in the Commission's licensee database. Special Counsel in the FCC Spectrum Enforcement Division Riley Hollingsworth wrote Larry L. Smith, KC7LJR, of Middleton, Idaho, and Larry J. Maniag, KD7JTG, of Payson, Arizona, on June 28 to inform them the FCC was suspending their Technician tickets for the remainder of their license terms or until each licensee provides a valid mailing address.

In his letter to Smith, Hollingsworth noted that on three occasions in late 2005, the FCC had been unable to deliver warning notices alleging deliberate interference to a 2-meter repeater system.

He told Maniag that the US Postal Service earlier this year returned as undeliverable two warning notices alleging deliberate interference with several repeaters.

Hollingsworth cited §97.23 of the Commission's Amateur Radio Service rules that requires each license grant to show the licensee's correct name and mailing address. The rule provides that "revocation of the station license or suspension of the operator license may result when correspondence from the FCC is returned as undeliverable because the grantee failed to provide the correct mailing address."

Hollingsworth cited the same rule to an Ohio licensee apparently tempting a similar fate. On June 26 Hollingsworth afforded Robert D. Reckner, W8IQJ, more time to respond to complaints involving his service as MIDCARS net control. The complaint alleges deliberate interference as a result of his starting the net on top of existing communications on 7.258 MHz in April. A June 1 letter enclosing the complaint came back to the FCC as undeliverable, he said.

In another failure-to-reply case, Hollingsworth notified William E. Kuth, KB2SGQ, of Utica, New York, on June 27 that

his license renewal application has been designated for dismissal. That action effectively eliminates Kuth's Amateur Radio privileges, and Hollingsworth reminded him of that fact.

In May, the FCC notified Kuth that his renewal application "could not be routinely granted" and had been referred to the Enforcement Bureau for review. That came in the wake of a Warning Notice for allegedly operating on 26.815 MHz without a license and causing interference on 10 meters. Additional complaints alleged that Kuth operated on 26.945 MHz.

Hollingsworth said postal records indicate that Kuth received the FCC inquiry on May 5 but did not respond. The letter to Kuth noted that the address on his renewal application differed from his actual mailing address. Kuth's Technician license expired in November 2004.

The FCC dismissed the upgrade application of Andrew O. Ojwang, KI4LTH, of Roswell, Georgia, based on the licensee's response to "numerous complaints about the operation of your station since the grant of your General class license," Hollingsworth wrote. Following the complaints, the FCC last October set aside Ojwang's General license and his renewal application, which reverted to pending status.

"Pursuant to your response dated May 31, 2006, your General class application is being forwarded to the Wireless Telecommunications Bureau for dismissal," Hollingsworth informed Ojwang on June 28. Complaints regarding Ojwang's on-air operation would have to be resolved before the Commission would consider an upgrade application, Hollingsworth advised. The FCC appears to have renewed Ojwang's Technician ticket for a full 10-year term, however.

MONTENEGRO DX FESTIVAL

Radio amateurs and equipment from all over Europe and from a few countries outside the continent converged this week on Montenegro -- the newest DXCC entity -- for the Montenegro International DX Festival. The event kicked off at noon on Thursday, July 20, with a salute to Montenegrin hams, the Amateur Radio Association of Montenegro and the country's telecoms authority and military.

The three-week Amateur Radio event is aimed at putting the tiny, new Balkan nation on the DX map in a big way. Seven stations identifying as 4O3T will be on the air from various locations. Nineteen-year old Nikola Ilic, YZ6AMD, made the first 4O3T QSO to start the festival, working DF3IU.

During the formalities, Montenegro Amateur Radio Union President Veso Babic, YU6A, and event organizer Ranko Boca, YT6A, welcomed all visitors to Montenegro. Well-known DXer Martti Laine, OH2BH, discussed some of the challenges facing ham radio as well as the opportunities for further talks with Montenegrin authorities. International Amateur Radio Union representative Hans Blondeel Timmerman, PB2T, promised to help Montenegro become an IARU member-society. Babic also reminded those on hand of Amateur Radio's valuable emergency communication effort following an earthquake in 1979.

Nearly four dozen operators from more than 10 countries are expected to serve as 4O3T operators during the DX Festival, which continues until August 13. ARRL CEO David Sumner, K1ZZ, and his wife Linda, KA1ZD, will join the event in progress.

Look for 4O3NT on or about these frequencies: CW: 1826.5, 3522, 7022, 10,106, 14,022, 18,072, 21,022, 24,892 and 28,022 kHz; SSB: 3795, 7055, 14,190, 18,145, 21,290, 24,945 and 28,490 kHz; RTTY: 7035, 10,135, 14,085, 18,105, 21,085 and 28,085 kHz; 6 meters, CW/SSB: 50,106 kHz. The United Nations admitted the Republic of Montenegro as its 192nd member on June 28, automatically making Montenegro the 336th current DXCC entity. Montenegro declared its independence on June 3 following a national referendum May 21.

There are fewer than 100 native radio amateurs in Montenegro. The International Telecommunication Union has not yet assigned a distinctive call sign block to the new country, although current Montenegrin radio amateurs have been using their YU/YT/YZ/4O-prefix call signs.

UK 5 MHZ EXPERIMENT EXTENDED

UK telecommunications regulator Ofcom and the Ministry of Defence okayed extending the 5 MHz Amateur Radio experiment until June 30, 2010, and adding two new channels -- 5368 and 5373 kHz (center frequencies). Under the expanded plan, the UK and the US now will enjoy three center-frequency channels in common -- the two new channels and 5405 kHz. The UK experiment, which began in 2002, was to have concluded July 31. The Radio Society of Great Britain (RSGB) says the extension followed discussions between Ofcom and the RSGB. Current notices of variation (NoVs) issued by the Radiocommunications Agency -- the former telecoms regulator -- still expire July 31, 2006, however, and Full license holders in the UK who want to continue using the 5 MHz frequencies will have to file a new NoV application. Applicants must explain how they plan to experiment on the 5 MHz channels.
